It is your responsibility to keep track of your VET Student Loan utilised. You will receive an invoice for upfront payment for the fee excess above the course cap where your course cap has been reached. Please note that the Institute also has a VET Student Loan Institute cap that once reached, will mean no further VET Student Loans are available in the calendar year, irrespective of a student's eligibility.

4. Not Have Exceeded Combined HELP Loan Limit - You must have sufficient Combined HELP Loan balance available. This is the cumulative total of any prior VET FEE-HELP, FEE-HELP, VET Student Loan and HECS-HELP* debts you have incurred. In 2026 students are entitled to **\$129,883** in VET Student Loan, VET FEE-HELP, FEE-HELP and HECS HELP combined. (*Only HECS-HELP debts incurred from 1/1/2021 contribute towards your Combined HELP Loan Limit). It is your responsibility to keep track of your HELP Loans utilised. You will receive an invoice for upfront payment for fee excess if your Combined HELP Loan Limit has been reached.

7. Student Declaration and Signature.

- I understand I am required to submit my Electronic Commonwealth Assistance Form (eCAF) for this VET Student Loan upon receipt of the eCAF email from the government, and that my eCAF submission must be finalized **prior to my course commencement**. This includes supplying my Tax File Number.
- I understand that once enrolled, Student Administration Services will check my eligibility, and record my VET Student Loan intention with the Australian Government. I understand if it is found that I am not eligible for a VET Student Loan, Box Hill Institute will invoice me for an upfront fee payment, and that payment is required to be made within the terms of the invoice (usually payment within 14 days). Alternatively, I understand I must formally withdraw before census date to not incur the tuition fees. - I understand if it is found that I have exceeded either my VSL Course Cap or my Combined HELP Loan Limit, Box Hill Institute will invoice me for an upfront payment for the fee gap not covered by the VET Student Loan, for payment within the terms of the invoice.
- I understand that I will be required to undertake progression eCAF submissions periodically throughout my course to signify my continuance in the course.

Next steps

- Enroll and pay remaining fees not being covered by VET Student Loan (VSL). Ensure you supply your citizenship evidence as part of your enrolment.
- Once enrolled, Student Administration Services will check your eligibility and record your VET Student Loan intention with the Australian Government.
- You will then receive an **email** from the government, asking you to complete the eCAF System online. The email will provide a **link** and **pass key** to enable you to do this. You must complete this as soon as possible and prior to course commencement.
- If it is found you are not eligible for VSL or have exceeded your VSL Course Cap or Combined HELP Loan limit, you will be invoiced for fee payment.

- **Gov** = Indicative full course tuition fee for students **eligible** for a government-subsidised place
- **FFS** = Fee-for-service indicative full course tuition fee for students **not** eligible for a government-subsidised place, or where the course is offered on a Fee-for-service basis only.

VSL is for tuition fees only. Non-tuition fees will also be charged for most courses and include a service and amenity fee and materials fees. These are not coverable by the VET Student Loan.
